NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES

- 1. Eligibility:** Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the Sweepstakes page located at <https://ieo.ucla.edu/glow-scavenger-hunt-rules/> and who are at least 18 and older as of the date of entry and is sponsored by The Regents of the University of California by and on behalf of UCLA Summer Sessions only (“Sponsor”). The Sweepstakes is only open to legal residents of the state of California, United States and is void where prohibited by law. Any person who is an employee, contractor, officer, director, agent or other representative of Sponsor, or of any of its affiliates or agencies, and involved in the administration of this Sweepstakes on behalf of Sponsor, as well as all members of such person’s immediate family and persons living in the same household with such person, are not eligible to participate in this Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. No purchase necessary to enter or win. Void where prohibited.
- 2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. You may enter only once per day and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. Sponsor shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 72 hours from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner will be selected.
